CRITERIA FOR ENTRY & ACCEPTANCE

- Artists must adhere to all entry criteria and submission guidelines for their work to be accepted into the show.
- Up to 5 pieces of artwork may be submitted. A maximum of 2 per artist will be accepted for hanging in the exhibition.
- Pieces cannot exceed MAXIMUM 48 inches (122 centimeters) wide and 60 inches (153 centimetres) high, including framing.
- Work must be completed since September 2023 and BE FOR SALE.
- Work must NOT have been accepted into ANY previous juried event.

- Acceptable entries will be original, two-dimensional works on any substrate, using paint, mixed media, or drawing medium. No photographs, prints of any kind or digital art will be accepted. Any digital reproductions or copied work will be disqualified. Works must be the original work of the artist. NOTE: Using photos as a painting reference is a long-held accepted practice, but the use of source material created by a professional photographer or stock photos is not allowed. Photos used for reference must be taken by the artist or provided by an amateur photographer with their expressed consent. The photographer's name and email address must be included in the submission under "description".
- Work must NOT have been created in a workshop or with an instructor's input.
- Submit entries in JPEG format, named with the painting name ONLY. The images should be of good quality; they should accurately reflect the colour and detail of each piece. They must be upright and cropped showing the artwork only, with no glare. Images of a diptych etc. should illustrate the height and width of the entire artwork. Remember: artwork is first judged by analysing the jpeg – ensure your photo does your piece justice! For help, email us.
- Work must be dry and professionally presented, either framed, cradle board mounted or on "gallery wrap" canvas with no staples showing. Wire must be at least 3 inches (7.5 cm) from the top at the centre. Hardware must hold the piece safely. The final decision to hang a piece will be made by the Gallery Committee.
- Any subject may be depicted, but SDAG reserves the right to refuse any artwork deemed unsuitable to hang in the gallery.

ENTRY FEES

- Fees are non-refundable
- Non-members: \$25 first entry; \$15 for each additional, up to 5 total.
- SDAG Members: \$20 first entry; \$10 for each additional (max 5).
- PREFERRED method of payment is online with a credit card.
- Artists may pay by cheque BUT MUST ENTER EARLY ENOUGH TO ENSURE THEIR CHEQUE ARRIVES BEFORE July 31, 2025.
- Mail cheques to South Delta Artists Guild, Box 18059, Tsawwassen Post Office, Delta BC, V4L 2M4 or hand deliver during open hours to 1710 – 56th Street, Delta, BC c/o "Golden Celebration Juried Exhibition". Attach a note with artist's name, contact information and painting titles. LATE PAYMENTS WILL DISQUALIFY ENTRY.

SALES OF ARTWORK

- SDAG will handle sales. Non- members: 70% of the sale price will be paid to the artist and a commission of 30% will be retained by SDAG. Members: 75% of the sale price will be paid to the artist and a commission of 25% will be retained by SDAG.
- Payments will be made within 30 days of the show end.
- Artwork prices must represent the artist's previous sales values, the insured value or be priced using some reasonable measure of value.
- GST will NOT be collected.
- Accepted artworks sold before the show opens or in the month following the show are still subject to a 25% commission to SDAG.
- An artist who withdraws an accepted work from the show breaks the contract (online entry form) and deprives other entries from being accepted, which may result in being prohibited entry from future juried shows.

JURORS

- Entries will be selected by the compiled scores of 3 qualified jurors. Jurors TBA
- Winners will be selected in 2 phases; an online phase to select the paintings that will make up the exhibition, then an in-person phase once the show has been hung. The jurors' decisions are final.

INSURANCE & SHIPPING

- Shipping instructions will be provided for accepted work.
- While the "Celebration Team" and SDAG will take all reasonable precautions to ensure the care of all artworks, SDAG is not responsible for any damage to work(s) that occurs while the piece is in transit or in the possession of SDAG.
- Artists are responsible for their own insurance.
- Accepted artists are responsible for delivery and pickup of their works on the dates specified in the schedule. Should those dates prove difficult, please contact us to arrange another date.
- All shipped works must be packed in sturdy, reusable containers and include clear instructions for installation and repacking/ shipping at the end of the show. Artworks arriving late may be excluded from the exhibition.
- Please check your entry carefully. All information must remain as submitted. No changes may be made once the entry is accepted for submission.

PUBLICITY and COPYRIGHT

- By submitting a work for inclusion in the Celebration Juried Art Exhibition, the artist agrees that the SDAG is permitted to use, edit, reproduce, publish, transmit and display images or footage of the artist's work(s), including those submitted by the artist as part of their entry, in films, video, signage, mailing, programs, online sales gallery and other forms of media including social media for the promotion and display of the Annual Juried Event, and other purposes as the SDAG may determine, including promotion and fundraising for the SDAG. The SDAG will not be responsible for the unauthorized use of the images or footage by third parties.
- Submission of your entry will be understood to indicate your agreement with these terms and conditions. Accepted artists will be required to sign a Loan Agreement agreeing to these terms.
- Images will be used for an online sales gallery.
